- While the information provided, including the information gathered online, will help us to match you with the most suitable mentor/mentee, Vic ICT for Women cannot guarantee that you will be matched according to your preferences.

- Respect the confidentiality of sensitive information and personal data entrusted to you by the organization or its members.
- Do not disclose or misuse confidential information without proper authorization.

## 3. Liability:
